12	WHEREAS, Conyers Street, Swift Street, Center Street, Boulevard from Swift to Main
13	Church Street from Center Steet to Rock Chapel Road, Rock Chapel Road - City Limits to Swif
14	Street, Main Street from Boulevard Drive to City Limits("City Streets") should not be subjected
15	to the heavy commercial truck traffic that has been a part of the streets history; and
16	WHEREAS, the City Streets run through residential areas, the residents of which endure
17	a steady stream of commercial trucks driving through their neighborhood on a daily basis
18	including dump trucks; and
19	WHEREAS, the City desires to prohibit access of commercial trucks on all City streets
20	except when it shall be necessary for the commercial truck to access a prohibited street to conduc
21	business; and
22	WHEREAS, the City's Code of Ordinances should be amended to provide for this
23	prohibition.
24	NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF
25	LITHONIA, GEORGIA as follows:
26	SECTION 1: That the City Council is authorized to prohibit the use of commercial trucks on all
27	city streets by removing commercial truck access to Conyers Street, Swift Street, Center Street

34	SECTION 4: That the City Clerk shall update the City's truck route map.
35	SECTION 5: That all ordinances and parts of ordinances in conflict with the terms of this
36	Ordinance are hereby repealed only to the extent of the conflict.
